

# Consent to Personal Data Processing

## Controller

Dale Ind. s. r. o., Company ID: 53 137 060, Address: Jenisejská 45A, Košice 040 12 (hereinafter referred to as the "Controller") is the controller of the registration form, in which this company processes your personal data as the data subject's personal data. The Controller processes personal data in accordance with the legal order of the Slovak Republic, taking maximum care of the privacy of data subjects and the protection of the personal data it processes.

## Reasons for Processing Personal Data

The processing of collected and provided personal data is an essential part of the Controller's activities. Without the processing of personal data, the Controller would not be able to provide its services to its employees, potential employees, business partners, or other data subjects to the required extent and quality.

## Basis for Personal Data Processing

The current legal regulation allows the processing of personal data on several legal bases, and personal data may be processed without the data subject's consent. If there is no other legal basis for the processing of personal data, personal data will be processed only on the basis of and within the scope of the data subject's consent.

## Provision of Data

Personal data processed by the Controller may also be processed by third parties, provided that the Controller decides so, or it is required to provide personal data by the legal order of the Slovak Republic. In cases where the choice of the recipient of personal data is up to the Controller, it always ensures a high standard of personal data protection for the data subject. Personal data of the data subject may be processed in the countries of the European Union and the countries that are parties to the Agreement on the European Economic Area. The transfer of personal data may only occur to third countries whose legal regime is considered by the European Commission to ensure an adequate level of personal data protection.

### **Personal Data of Another Data Subject**

In the case that I provide personal data of another data subject in the form, I confirm that I provide these personal data to the Controller with the knowledge and consent of the other data subject in accordance with the Personal Data Protection Act. At the same time, I confirm that this other data subject is acquainted with all the information provided in this consent as well as other information pursuant to § 20 of the Personal Data Protection Act.

### **Personal Data Security**

The Controller processes personal data manually or using electronic information systems. The Controller has taken all necessary measures, both technical and personnel and control measures, to ensure the highest level of personal data protection.

### **Rights of the Data Subject**

The data subject has the right to:

- a) request access to personal data concerning the data subject from the Controller,
- b) correction, deletion, or restriction of the processing of personal data,
- c) object to the processing of personal data,
- d) data portability,
- e) file a complaint or motion to initiate proceedings with the supervisory authority, which is the Office for Personal Data Protection of the Slovak Republic,
- f) withdraw their consent to the processing of personal data at any time.
